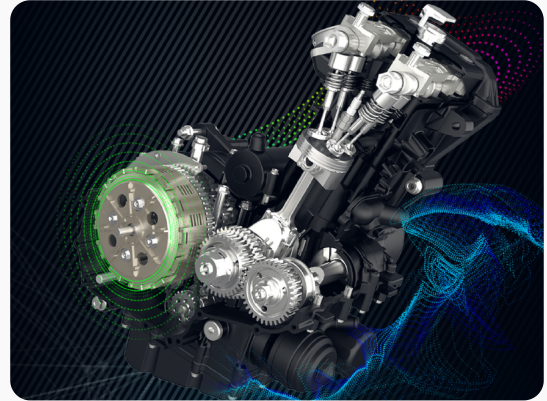

BRAKES & TYRES
